Dear Friends in Christ,

saint. (In Latin, *Simul iustus et peccator*) We are redeemed by God's mercy and invited to live in faith and love each day.

A Joyful Note from the Music Ministry

During the month of October, we experienced several meaningful updates in our music ministry — all done with the shared goal of deepening our worship life together. We are grateful for the hands, gifts, and hearts that continue to shape and support music here at Holy Trinity.



1. Our Grand Piano Is on the Move!

Thanks to the generous support of a member of our congregation, a permanent piano dolly was purchased and installed on the sanctuary's grand piano. This now allows the piano to be moved more easily into the front of the sanctuary — where it is already being used more frequently to help lead worship. We also look forward to the possibility of hosting musical performances in the future, such as university or high school recitals and other concerts that bring music and community together, as now the piano is mobile!

2. Improving Our Worship Sound Experience

Jason partnered with Ben from Milwaukee Sound Machine to lovingly "fine tune" our sound system. These changes have:

- Enhanced the overall sound quality in the sanctuary
- Balanced sound more evenly between speakers
- Improved audio levels for our livestream worshippers
- Added a front microphone to help support choir-led worship from the front when desired

These updates help ensure that everyone — whether in person or online — feels included in the worship experience.

3. A Gift of Percussion

We were blessed with the donation of an acoustic drum set! Work is being done to shape its sound so that it adds warmth and rhythm without overpowering our space. A heartfelt **thank you to Doug Westphal** for his steady support and care in helping make this possible.

4. Our Monthly Rhythm of Worship Music

We will continue to celebrate a variety of musical styles in worship each month:

- 1st & 2nd Sundays Traditional ELW liturgy and hymns with organ and piano
- 3rd Sunday A blend of hymns and contemporary praise music, led by piano and/or guitar
- 4th & 5th Sundays Praise Band Sunday, featuring vocalists, guitar, bass, and percussion

Our hope is to continue sustaining a full band for Praise Band Sundays — including having a full band (bass, guitar, percussion, piano and 2-3 vocalists) present as part of **Christmas Eve** this year.

Thank you, Holy Trinity, for your ongoing support, encouragement, and joyful participation in worship.

Step Up Your Giving - From The Heart

A Stewardship Reflection on Generosity and Purpose

Where Your Heart Is

As we enter this year's Stewardship Campaign, we are reminded of the words found in Matthew 6:21: "For where your treasure is, there your heart will be also." This simple yet profound message invites each of us to reflect on what truly matters in our lives and how our choices reveal the priorities of our hearts.



Stepping Up: Why Heartfelt Giving Matters

Each year, we are invited to reflect on the many blessings in our lives and consider how we might give back to the faith community that nurtures us. Stewardship is not just about finances — it's about responding to God's love with gratitude, embracing giving as a joyful and meaningful act. This year's stewardship theme, "Where Your Heart Is", calls us to examine not just what we give, but how and why we give.

Giving As an Expression of Faith

Stewardship is rooted in the understanding that everything we have is a gift from God. Our time, talents, and treasures are entrusted to us not only for our benefit, but so that we may use them to serve others and build up God's kingdom. When we give from the heart, our actions become an expression of faith — an offering of gratitude and trust in God's continued provision.

Moving Beyond Obligation

It's easy to see giving as a duty, something we check off a list. But stewardship is most powerful when it becomes an act of love. Consider how your gifts — large or small — help support ministries, care for those in need, and create opportunities for spiritual growth. True generosity flows from a place of compassion, hope, and commitment to something greater than ourselves.

How to Step Up Your Giving

- 1. *Pray About Your Commitment:* Ask God to guide your giving and open your heart to respond in faith.
- 2. *Reflect on Your Blessings:* Take time to consider the abundance in your life and what you can joyfully share.
- 3. *Give Intentionally:* Set a goal for your giving whether it's increasing your financial pledge, volunteering your time, or sharing a special skill.
- 4. *Involve Your Family:* Invite conversations about stewardship at home and model generous living for the next generation.

Regarding Legacy & Efficient Non-cash Giving

Many of us have focused on providing for our loved ones most of our adult lives. We have witnessed our families grow and become financially independent. As a community, we are living longer, and our adult children and their families have or may still benefit from our support. Our longer lifespans often mean that they have become mature and self-sufficient right before our eyes.

For many, the reality is that we have exceeded our expectations and overcome our fears regarding financial security. Some within our church community are experiencing the ability to pledge and share an increasing portion of ourselves [often referred to as the 3Ts...Time, Talent and Treasure]. Holy Trinity Lutheran Church (HTLC) strives to be a worthy recipient of a significant allocation of your 3Ts each year and upon your final allocation.

The ultimate gift a member can express is the inclusion of HTLC as a beneficiary in your Will or Trust. As a 501(c)(3) charitable organization, legacy gifts designated by individuals in their Will or Trust could be beneficial in your estate planning. Designating a percentage of your estate to HTLC (example 10%) provides a Legacy to our church while only minimally reducing the allocations to your family or other designated beneficiaries. As the year closes, I will share a real-life example occurring here at HTLC.

It is recommended that everyone has a Will and/or Trust to handle your estate administration. If you do not, please consider getting something in place very soon. If you have a Will or Trust, it is recommended that you review it every 3-5 years to make sure it still expresses your wishes and includes provisions necessary to carry out your wishes. Whether you are creating your first Will or amending your existing Will or Trust, please consider including HTLC in your final bequests.

Legacies can also be created while you are still an active member of our church. Donating cash, appreciated securities or by qualified IRA designation. All methods are effective and HTLC benefits and appreciates all that you share of your treasures. With that stated, the most tax efficient gifting technique available to our members who are age 70½ or older and have an IRA is a Qualified Charitable Distribution (QCD). While a QCD does not qualify for a charitable deduction, it eliminates the inclusion of IRA income from taxpayer returns. IRA funds are directed from the taxpayer's account to your designated charity or charities. The IRA custodian disburses funds directly to your qualified charity(ies).

We have worked with our members' IRA custodians to arrange for this type of QCD donation. Individuals can reduce or eliminate their Required Minimum Distributions (RMDs), lowering their taxable income. Reduced RMDs will lower taxable income. Less income means lower taxes. An often-overlooked benefit of using QCDs to donate annual RMDs is that lower income increases the potential to retain more of your Social Security income. Medicare deductions and income taxation of these benefits are based on your total income. If you have already withdrawn your 2025 IRA RMD, consider contacting your IRA custodian and instruct them that next year, you would like to designate a portion of your RMD to HTLC using a QCD. You pay less in taxes, and your entire designated amount benefits our church.

It is worth noting that many individuals and couples have been unable to itemize deductions on their personal income tax return in recent years because of the increased standard deduction. Consider bunching your charitable giving into one tax year. Donate some of your 2026 pledge commitment in December 2025 to "double up" for tax savings. We will record it correctly based on instructions you provide with your donation(s).

If you're thinking about selling appreciated stocks, bonds, mutual funds or ETFs, consider gifting shares of any of these non-cash assets directly to eliminate the capital gains tax you would pay on the gain on sale. HTLC can accept these securities and will work with your advisor to directly transfer anything you direct from your investment account to the church's investment account. You will receive a statement from the church confirming the market value of the assets donated as a charitable deduction. You save your cash, including the tax savings by avoiding capital gains tax on investments you donated directly and did not sell.

Giving bunched gifts from non-cash assets makes this easier because it does not reduce the cash you need for living. If this sounds like it might be useful for you, see your tax advisor as soon as possible and authorize any non-cash donation by mid-December so it can be completed by year end. You will receive a 2025 tax deduction even if you designate amounts in support of your 2026 pledge. If this is not a viable strategy for your 2025 tax year, discuss and consider this strategy for 2026 and future years.

See your tax advisor in the coming weeks to plan strategies that apply to your tax situation. While your Church Treasurer cannot give you specific tax advice, I am willing to discuss these methods with you if you have any questions. Email the office and your message will be forwarded to me in a timely manner. Thank you for all that you do for Holy Trinity Lutheran Church.
